Thank you for your interest in the 2012 International Cultural Exchange Program (ICEP2012)!

Since 2009, the Carolina China Council has administered educational and cultural exchange programs to promote cross cultural understanding and peace for students enrolled full-time in a high school or college in North Carolina or China. Such exchange programs enable North Carolina students to travel to select regions in China to experience and explore the diverse Chinese culture and society and help to bring students from China to experience the U.S. educational system and explore U.S. culture and values.

The ICEP2012 is pleased to extend this opportunity to visit Xinjiang Uygur Autonomous Region of China for adult supervisors and college undergraduate and graduate students from the State of North Carolina. This three week culture exchange program will provide fun-filled field trips to exotic natural scenic and historic sites in Xinjiang, classroom instructions in Chinese language, art and culture, and cross-culture project development, diversity, and Xinjiang Uygur culture, history and society.

The Carolina China Council, a Raleigh based NGO, will implement the **ICEP2012** in cooperation with Xinjiang University and the Government of Xinjiang Uygur Autonomous Region of China. The goal of this project is to foster cross-cultural understanding and mutual respect among college students and adult leaders from Xinjiang and North Carolina, empowering them with the skills and multi-cultural knowledge to become people ambassadors in a globalized world. Sixteen student participants (full-time undergraduate and graduate students) and four adult leaders will represent the State of North Carolina.

The program will include two-way exchanges between Xinjiang and North Carolina. The trip to Xinjiang will occur between June 10 and 30 2012, with the return trip of Xinjiang participants to North Carolina occurring in summer 2013.

What to Expect as a Participant

The **ICEP** focuses on cross-cultural opportunities for sharing and learning and building a lasting friendship among the participants and the people they represent. Participants are selected from a broad variety of backgrounds and ethnic groups across the state. All activities will take into consideration of the varying ethnic and cultural background of the participants and develop a multi-cultural program for sharing and mutual understanding.

All participants of the program should:

- Have a strong desire to learn from others
- Show the ability and willingness to share best practices and lessons learned from their own experiences
- Be open to experiencing new cultures and ways of thinking
- Have a desire to share their own culture and values with students and adults from different cultures, religions and varied backgrounds without prejudice
- Work with diverse groups throughout all aspects of the programs
- Be flexible in working with other participants and coordinators during scheduling, travel, etc.

What to expect during the program:

- Meetings with Carolina China Council prior to taking the trip to learn about trip logistics and mission goals
- Cultural activities utilizing the local surroundings such as hikes, outdoor activities, sporting events, field trips to local attractions, museums, etc.
- Classroom activities on sharing and learning of language, culture, and arts with other groups
- Free time to interact with other participants
- Communicate with people who speak a different language
- Long days with some early mornings and late nights
- Dance and sing with Uygur minority students
- Eating Chinese and Uygur minority food which may be outside of your comfort zone; be ready to try new things!

Who is eligible to apply as an adult participant?

Adult participant applicants must:

- Between the ages of 30 and 60
- Currently working as a teacher, community leader or NGO employee
- Experience supervising college students
- Have United States citizenship and current residency in the State of North Carolina
- Submit a complete application, including photograph and contacts addresses for two references

Note: American adult participants must be fluent in English, but a knowledge of Chinese is not required.

What are the criteria for selection?

Adult participant applicants will be evaluated on the following characteristics:

- Proven track record of participating in community activities
- Demonstrated leadership skills and an interest in international affairs and community service
- Demonstrated ability to relate to people of other cultures and backgrounds
- Demonstrated interest in assisting youth to become productive and responsible members of the society
- Established long-term goals to remain in teaching position or other positions of influence to young people
- Good social and communication skills
- An energetic, positive attitude

Adult participating in the ICEP are expected to fully participate in all activities and bring their expertise in their field to inspire and encourage student participants to facilitate cross-culture dialogue. They will not only serve as a mentor and role-model but also assist in enforcing guidelines and working with students to better engage with other participants and peers.

What is covered?

The Xinjiang Government, in conjunction with Xinjiang University, will pay for round-trip airfare to and from the United States to Xinjiang, program and field trip costs, ground transportation, lodging and meals, cultural activities, and educational materials, to selected student and adult participants through the “North Carolina - Xinjiang ICEP Scholarship”. Each scholarship has a minimum value of US\$2000.

Background Information about Xinjiang Uygur Autonomous Region

About Xinjiang

The Xinjiang Uygur Autonomous Region, also called Xin for short, is located in northwestern China. Largest in area in all the province-level administrative regions of China, the Xinjiang Uygur Autonomous Region covers an area of 1.66 million sq.km, one sixth of Chinese territory. Situated in the hinterland of Eurasian continent, Xinjiang of China borders eight countries such as Russia, Kazakhstan, Kirghiziastan, Tajikistan, Pakistan, Mongolia, India and Afghanistan. The geographic position of Xinjiang makes it very important in strategy. In history, Xinjiang served as the key controlling section of the well-known Silk Road, while now it is an unavoidable part of the railway leading to the second Eurasia Continental Bridge.

Xinjiang, called Western Region in ancient times, has been an inalienable part of China from ancient times. In 60 B.C., Xinjiang officially became a part of China's territory for that year central government of the Western Han Dynasty founded the West Region Frontier Command here. In 1884, the government of the Qing Dynasty established Xinjiang Province. In 1949, Xinjiang was liberated through peaceful means. October 1, 1955 saw the establishment of the Xinjiang Uygur Autonomous Region.

Presently, there are 14 prefectures (including prefectures, autonomous prefectures and prefecture-level cities) and 88 counties (including cities and cities at county level) under the government of the Xinjiang Uygur Autonomous Region, including 33 counties (county-level cities) in border areas. The Xinjiang Production and Construction Corps (XPCC) is an important component part of Xinjiang and has 174 regimental agricultural and stockbreeding farms under it. By the end of 2004, the population of Xinjiang had reached 19.6311 million.
